



About Metaverse and Adult Metaverse

In October 2021, Facebook founder, Mark Zuckerberg, officially introduced the concept of the "Metaverse" and announced the company's commitment to building a fully immersive virtual world. The company was renamed from Facebook to "Meta" so as to reflect its focus on the development of the Metaverse.

Currently, the Metaverse remains in its infancy. Global consulting firm McKinsey & Company predicts that by 2030, the market size of the Metaverse will exceed \$5 trillion. People are gradually transitioning from the traditional internet to the Metaverse, a process that is expected to take more than 20 years, with a clear acceleration in its later stages.

Among the top 10 websites in the world by traffic, Pornhub (5.4 billion visits per month) and Xvideos (3.6 billion visits per month) are two adult websites. Traffic to adult websites accounts for over 30% of global internet usage, with more than 100 million visits daily, two-thirds of which come from men and one-third from women. In the future, most traditional adult websites are expected to be replaced by innovative adult Metaverse platforms.

About Web3.0

There is no universally accepted definition for Web 3.0. However, the mainstream view lies in that it represents an improvement over Web 2.0. In the Web 2.0 era, data and profits were concentrated in the hands of large tech companies. Web 3.0 is aimed to return control of data and profits to users through decentralized technologies.

Web1.0

Web2.0

Web 2.0, also called the "Mobile Internet," granted users with both "read" and "write" permissions for information. While users created immense value for platforms, all rights still belonged to the platforms. Representative companies include Facebook, Alibaba, and Tencent.

This value internet, which represents the highest form of human social networking, is poised to become one of the greatest opportunities for the internet in the next three decades. With the evolution of the value internet, it will not only unite users and companies as shared beneficiaries but also foster integration among companies to form various ecosystems. In the future, business competition will no longer be between individual companies but between ecosystems.

Web3.0

Web 3.0, often referred to as the "Value Internet," grants users with the rights to "read," "write," and "own" information. It enables users to share profits with platforms. In the Web 3.0 era, platforms share all earnings with users. The more active users are and the more value they contribute, the greater the rewards they receive. These rewards are recorded using tokens issued by the platform. These tokens leverage blockchain technology and can be exchanged for company equity and dividends, creating a value-driven internet where everyone can participate, contributions are recorded, and every contribution has value.

About NFT



NFT(Non-Fungible Token)

NFT (Non-Fungible Token) is not only a crowdfunding method to support project creators but also a unit of data on the blockchain. Each token represents a unique piece of digital information, and serves as an electronic certificate or proof of ownership for virtual goods. Due to its non-fungible nature, NFTs can represent digital assets such as artwork, audio, videos, ingame items, or other forms of creative work. While the digital work itself can be copied infinitely, the tokens representing them can be fully tracked on their underlying blockchain, so that buyers get proof of ownership.

NFTs solve the copyright issues of digital collectibles, which significantly boost the development of the digital collectibles market and create numerous astonishing transaction records. For example, Beeple's Everydays: The First 5000 Days was sold for \$69.3 million through auction house of Christie in March 2021, becoming the most expensive NFT transaction to date. Several other works have also sold for over \$10 million each. RTFKT is a company specializing in creating virtual sneakers, digital fashion items, and NFTs. In December 2021, it was acquired by Nike. Some of the digital sneakers released by RTFKT now sell for over \$50,000 per pair, blending traditional sneaker culture with the emerging world of virtual goods. Inspired by RTFKT, other fashion categories such as hats, jackets, pants, belts, and accessories have also seen brands launching their own NFT digital collectibles.

In the adult industry, where works often lack legal and copyright protection, creators confront with significant limitations on their enthusiasm. NFTs can address this issue. Moreover, assets in the metaverse, such as land, clothing, and in-game items, can all be minted into NFTs, granting members with true ownership of their purchased assets. These assets can also be traded on markets outside the metaverse, which further enhances their value and utility.



Two Key Roles — Lord & Resident

The "UAA META" (hereinafter referred to as the System) establishes a total of 2,000 lord seats in the Lord Era. As platform shareholders, lords enjoy taxation rights, dividend rights, priority rights, and advisory rights.

To become a lord, individuals must purchase 1,000 USDT worth of UAA coins in the market and transfer them to a designated address for locked staking (released gradually over 12 months based on a gold standard) to exchange for a Founder Lord NFT Badge, which serves as proof of lordship. The Founder Lord NFT Badge is limited to 2,000 pieces.



Lord's Rights	Description of Rights
Right 1	At the system's initialization, each lord is assigned 500 real residents, and thereafter, no fewer than 500 real residents are allocated annually.
Right 2	Lords receive 50% of the profit generated from the spending of their directly referred individuals as a referral reward.

Right 4	Lords can share 5% of the platform's profit as an annual dividend.
Right 5	Lords receive a lifetime Supreme VIP membership on uaa.com, granting them free access to all content and features.
Right 6	When a new lord emerges within a territory, 10% of the new lord's income is shared based on the proximity of the invitation relationship.
Right 7	A lord who recommends more than 20 other lords will earn the title of "Creator" and receive an additional 2% of the profits generated from all resident consumption

Phase 3: Metaverse World with Realistic Role-Playing


- All kingdoms and cities are fully integrated into the metaverse, so that players can travel between cities and admire artistic creations of others.

Smart intimate devices can be used alone or randomly paired according to geographical location, and both parties can make voice or video calls through VR glasses during use.

In the metaverse, smart intimate devices can replicate the other person's real physical conditions and movements to the greatest extent when matched with a desirable player. Combined with the virtual appearance and voice of the other player - customizable to one's ideal "dream partner"- the experience becomes even more exciting and fresh.

In some countries or regions, e-commerce and social platforms must comply with national laws and regulations, imposing strict restrictions on adult-related content, products, or services. This has long suppressed a massive market, which now primarily operates covertly through underground channels. Such lack of regulation has led to rampant fraud and an extremely disorganized market.

Privacy Protection Secure Transactions

UAA META is aimed to establish an entirely new trading system through blockchain technology. Transactions are conducted via blockchain tokens to safeguard privacy and security of users. Additionally, the platform provides a review system and escrow support. After transactions, users can report scams, at which point the platform will withhold funds, preventing scammers from accessing the money. This mechanism further protects users' funds and personal safety.

Diversified Trading Products

The trading system provides convenient trading support for each resident, and residents can trade physical goods, virtual goods and services with each other.

- Virtual Item Transactions: Private photos, private videos, confidential information, and other virtual assets.

- In the POVA system, valid activities may include completing transactions, executing smart contracts, or performing other actions that contribute to the development of the blockchain network. Only activities that meet specific criteria are recognized as valid and gain consensus approval.
- In UAA META, inviting new users, creating content, publishing posts, providing services or goods, reading, watching, subscribing, tipping, sharing, commenting, or reposting, reviewing and verifying content are defined as effective activities and are rewarded accordingly
- "UAA META" encodes the invitation relationships and reward system
 into blockchain smart contracts, ensuring that the reward
 mechanism operates continuously and autonomously, akin to a
 natural law, sustaining indefinitely.


